## 4. FIRST-AID MEASURES

Other adverse effects include respiratory depression, gastrointestinal disturbances, skin reactions and confusion. The most toxic effects of overdosage result from profound central depression and include coma, respiratory and cardiovascular depression with hypertension and shock

leading to renal failure and death.
